## **Terms of Use**

Through the website (www.theegg.gr), we provide you with the opportunity to stay informed about the egg business accelerator (hereafter referred to as "egg"). Before using this website, please read the terms governing its use carefully.

## **Definitions**

- 1. "Website" refers to the website at www.theegg.gr.
- The use of the first-person plural ("we") refers to the public limited company (société anonyme) Eurobank SA (hereinafter referred to as "Eurobank"), at 8 Othonos Str., GR-105 57, Athens, General Electronic Commercial Registry (GEMI) No. 154558160000, TIN 996866969, Tax Procedures and Service Centre of Attica.
- 3. The use of the second person singular/plural ("you") refers to visitors of the Website.
- 4. "Terms" refers to the terms of use that follow.

### The effect of the Terms

The Terms govern your use of the Website.

Your use of the Website implies your full and unconditional acceptance of the Terms. If you disagree with and do not wish to be bound by these Terms, you must not use the Website.

#### Amendment of the Terms

We have the right to amend these Terms whenever we deem it necessary and without justification. Each amendment shall enter into force as soon as it is posted on the Website.

You should check for any amendments to the Terms. Your continued use of the Website after the posting of the new Terms implies your acceptance of said amendments.

## Your obligations
